Chair's Corner

Another academic year has come to a close with another class moving on after graduation. The department has welcomed our new class of residents and fellows who arrived on July 1, 2006.

We have completed another successful PM&R Board Review Course (number 18) with about 200 paying registrants plus another 30 non-paying attendees including residents, fellows and faculty. The course improves each year and the KMRREC Education Department does a great job of organizing and monitoring it.

This year's resident pool was once again very strong. We are proud of our Match results (page 6). We interviewed 90 candidates to fill 8 slots and went down to 19 on our Match list.

The negative coverage of UMDNJ in the media has continued, centering on various allegations of misconduct. The University currently has an interim President, and each of the three medical schools has an Interim Dean. Until permanent leaders have been appointed to these critical posts, it will be difficult for the school to recruit strong faculty and strong program leadership.

Dr. Susan Garstang is doing an outstanding job as our Residency Training Director. The PM&R Residency Review Committee and its parent, the ACGME, are significantly changing the training requirements to more objectively measure the six "general competencies." She is working hard to bring our department into compliance with these important standards.

The Department has just completed its internal review of my stewardship as a Chair of the department. This is the third review I have undergone during my 19 years at New Jersey Medical School. While each has been favorable, none of these reviews have resulted in any additional resources to the department. I am not optimistic that the trend will improve with this one, especially considering the apparently serious financial problems now facing the State of New Jersey and UMDNJ.

KMRREC's lease and its options at Kessler West will expire in 2010. The KMRREC Board had a planning meeting on June 19 devoted to selecting a permanent site, but a final decision has not been made. KMRREC currently occupies 23,000 square feet and has planned for 40,000 at its new location. This is a critical issue for the department's research mission as we have no designated research space on the Newark campus.

This year's Teacher of the Year was William F. Micheo, M.D., Chair and Program Director at the University of Puerto Rico School of Medicine. His topics were: "Current Concepts in Rehabilitation of Knee Injury," and "Sports Medicine Approach to Rehabilitation of Back Pain," "Rehabilitation of Shoulder Injury in Overhead Sports," and "Cervical Spine Injury in Sports."

The recipient of this year's Annual Teaching Award was Peter P. Yonclas, MD. Jeffrey Fossati, MD (residency '95) was the recipient of this year's Alumni Award, and Gary Chimes, M.D., Ph.D. received the Resident as Teacher Award. At our Wednesday morning lectures, there was also a presentation of a bronze plaque of Dr. Scott Nadler, which will be hung in the office suite in the Doctors Office Center in Newark where Scott worked. He is greatly missed. Unfortunately I was unable to attend this year's graduation activities due to a newly-torn Achilles' tendon, but I was there in spirit.

Please keep in touch as your news is what makes this publication interesting.

Residency Program Director's Column

Greetings! Hope all of you are well.

My first year here as Program Director is drawing to an end; and I have finally experienced all of the events in a year of the residency. My focus this year has been on enhancing the residency program, both by being available for the residents and by adding elements to the program. One of the main things I've worked on is making the website more informative and user friendly. We've added a Residency Home Page, and the residents composed bios and shared pictures of themselves to add a personal touch to the website. I remain the webmaster, and am always looking for content, so if you want more information on the website or have ideas for developing the alumni section, please let me know.

Another focus of this year has been to make sure we are in compliance with all RRC requirements. This has involved

implementing an on-line evaluation system ("MyEvaluations.com"), which allows residents and faculty to complete evaluations quickly, and allows confidential evaluations of faculty, rotations, and the program as a whole. We are also ensuring strict compliance with the duty hours requirements which are now in force.

The OSCE was held on May 11th and 12th, and we now are having the residents participate in a nine-station OSCE (so those of you who remember going through six stations can sympathize with how much time and effort this takes on everyone's part). We made this change so that the results are reliable and valid, which allows me to make curricular changes to the program based on the results we obtained. The OSCE is still primarily used for program evaluation, but the results are also kept in the residents' portfolio, which is a folder of assessments to demonstrate ongoing professional development (as required by the RRC).

The Board Review Course went well again this year, and was interesting for me as it was my first time co-Coordinating a large national course such as this. The goal for next year will be to make sure those of you who are studying for the ABPM&R Maintenance of Certification (MOC) exam receive information about the Board Review Course, as the material covered will help you to prepare for your MOC exam.

Along those lines, as many of you are aware, the American Board of PMR has started the Maintenance of Certification (MOC) process, which includes tracking yearly CMEs and requiring most diplomates to recertify every ten years by taking a computerized MOC exam (very much like retaking Part I of the Boards). The MOC process also involves conducting Quality Improvement projects (see Dr. DeLisa's recent article in the blue journal as listed under "Faculty Publications"). In the future, the ABPMR plans to add more steps to the MOC process, which will require more physician involvement. The most important thing at this time is to make sure that you are diligently tracking your CME credits, and paying the yearly fee to the ABPM&R for the MOC program. Also, check when your certificate expires, and plan to take the MOC exam before that date. More information about the MOC process is available at www.abpmr.org.

As the academic year ends and graduation passes, the senior residents are preparing to go out into the world and put all their hard-earned knowledge and skills to good use. I have asked some of our more recent alumni for feedback on what you learned during residency, but I would greatly appreciate receiving your input on what we DIDN'T teach you that you really needed to know. Developments at UMDNJ

Since our last issue, there have been a number of important developments at UMDNJ involving allegations of misconduct. First, the University has executed a "deferred prosecution agreement" and a "monitor agreement" with the federal government in order to avoid criminal prosecution. These agreements are expected to remain in effect for two to Judge Herbert Stern, UMDNJ's federal three years. "monitor," has moved his office on-campus and has been granted wide discretion in identifying potential misconduct at the University. In carrying out his investigative duties he has been gathering documents such as contracts, policies, personal calendars and agreements, and has hired various consultants such as attorneys, accountants and forensic auditors to assist him. The first report from Judge Stern on his findings is available at this link, and the appendices are available at appendices. Secondly, several UMDNJ board members have resigned, many under pressure from Gov. Corzine, and the Governor has appointed several replacements, including new UMDNJ board chairman Robert J. Del Tufo, Esq.

Thirdly, UMDNJ President Petillo resigned in February, and Bruce C. Vladeck, Ph.D. was subsequently appointed as UMDNJ's interim president. Dr. Vladeck is a nationally recognized health care expert who was previously a principal at Ernst & Young in New York City, where he directed the firm's academic medical center service line. From 1993 to 1997, he served as administrator of the Health Care Financing Administration, where he directed the Medicare and Medicaid programs. Before joining HCFA, Dr. Vladeck was President of the United Hospital Fund of New York for ten years. He received his BA *magna cum laude* from Harvard, and an M.A. and Ph.D. in political science from Michigan. It is expected that the search for a permanent president of UMDNJ may require a year or longer. Fourth, newly discovered billing irregularities at UMDNJ have brought the total amount of questionable revenues to approximately \$75 million. The latest revelations involve Medicaid charges on behalf of University Behavioral HealthCare, the university's mental health division. Fifth, under pressure from the federal monitor, several senior executives and academic leaders at UMDNJ have either been dismissed or have resigned, including the Dean of UMDNJ's School of Osteopathic Medicine, the Senior VP for Academic Affairs, a senior associate dean, several vice presidents and several financial executives. Many of these terminations have involved allegations of financial or ethical misconduct.

The University now has interim deans leading all three of its medical schools, an interim President and a variety of key administrative posts that have also been filled with temporary appointees. Meanwhile, the State of New Jersey has rolled out a new set of ethics guidelines for all State agencies that impose new limits on faculty and resident activities. In an attempt to comply with these new guidelines, our program has been forced to eliminate residents' lunches provided by drug companies at the Wednesday didactics, due to the possible conflict of interest such meals are believed to engender. New forms have been developed requiring UMDNJ faculty to obtain written permission before they can serve on committees, write board exam questions, hold offices in professional organizations and perform similar activities for organizations outside of UMDNJ. Other new forms require approval before faculty may attend any meeting, conference, seminar, speaking engagement, symposium, training course, ground-breaking, ribbon-cutting, meal, open house, cocktail party, fundraiser, holiday party or social function. Caps have been placed on reimbursement for out-of-pocket faculty expenses, even for travel and dues that are paid with non-UMDNJ funds generated through the faculty practice. In some cases auditors have retroactively denied travel expenses incurred by faculty, if cheaper modes of transportation or accommodation were subsequently determined to have been available. These new restrictions have damaged morale on the part of our faculty and trainees, just as they have in other UMDNJ-based departments. The NJMS Dean and other deans have attempted to secure an "academic exemption" to these new regulations, many of which were developed by the State to regulate the casino industry, race tracks and similar State-supervised activities.

Meanwhile, construction activity continues unabated. A new 816-vehicle parking deck has opened at UMDNJ's Newark campus, and the New Jersey Medical School/University Hospital Cancer Center is scheduled to open in August 2006. This is currently the largest construction project on the Newark Campus. The facility will accommodate clinical and research space as well as a research lab expansion and a vivarium.

Self-Study Committee Reports on Dr. DeLisa's Stewardship

In accordance with New Jersey Medical School bylaws, a PM&R Self-Study Committee was formed in 2005 to evaluate Dr. DeLisa's stewardship over the past five years. Under the leadership of Dr. John Bach, Professor, this committee completed its assignment in May 2006 when it submitted three "deliverables" to the Dean's Office.

- Status report on recommendations from the previous external review in 2000
- Report of Self-Study Committee
- PM&R Department "database" (more than 1,500 pages)

At this point the Dean's Office may either assign an internal NJMS-wide committee to evaluate the PM&R Department, or it may schedule several external reviewers for a site visit, possibly during the fall. These external reviewers will then submit a separate report to the Dean. Hopefully these remaining phases of the stewardship review will be completed before the database becomes out-of-date, and hopefully this process will result in additional resources to the department.

Dr. William Micheo Receives NJMS Teacher of the Year Award in PM&R

William F. Micheo, M.D., Director of Physical Medicine, Rehabilitation & Sports Health at the University of Puerto Rico School of Medicine, was presented with the 2006 PM&R Teacher of the Year Award on June 7, 2006. Dr. Micheo has served as director, team physician or co-director of the Puerto Rican Olympic Delegation at 11 international events, including all quadrennial Olympic competitions since 1992. Dr. Micheo was also recently elected to serve on the board of the ABPMR. In keeping with previous years, Dr. Micheo was the principal speaker at our graduation activities on June 6-7, 2006. Our department has been fortunate because for the past 19 consecutive years, our first-choice speakers have always accepted our invitations to come to NJ to teach our residents on our specific graduation dates.

The 2006 Match went very well, with the eight slots within the class of 2010 being filled by going down to number 19 on our department's rank order list. Competing programs that were relatively popular among applicants whom we ranked among our top 30 candidates included Harvard/Spaulding, Northwestern/RIC, Jefferson and Michigan. Two residents who matched with our program trained at NJMS, two at Cornell, and one each at New York Medical College, New York Osteopathic, Robert Wood Johnson, and Rochester.

Beginning in July 2008, OB/GYN will be the only GME program within the Atlantic system that will be integrated with New Jersey Medical School. University Hospital in Newark has agreed to pick up one additional PM&R resident slot on an interim basis starting in July 2006, bringing the total number of slots at UH to five. On July 1, 2009, the number of slots funded by UH will revert back to four. It is anticipated that Kessler Institute will pick up one additional slot beginning in July 2007, bringing the number of slots funded by KIR to 11. By academic year 2009-2010 and continuing thereafter, the total number of residents in the PM&R residency program is expected to be reduced to 24.

Objective Structured Clinical Examination Benchmarks General Competencies

This year's "OSCE" was held on May 11-12th at UMDNJ in Newark. This year the OSCE consisted of nine stations, using the clinical skills facility at UMDNJ. In addition to the clinical simulation component, the exam included a 75question written examination, a 60-question slide/videotape recognition examination and the evaluation of a scientific paper. Our "OSCE" is used to objectively evaluate our trainees in the six general competencies, a process that takes one half-day for each resident. Several other PM&R residency programs across the country have adopted various components from our program as they develop their own "OSCEs."

Residency Program Adopts Model

Resident-Faculty Compact

Early in 2006 the Association of American Medical Colleges released a proposed "<u>Compact Between Resident Physicians</u> and <u>Their Teachers</u>." This compact is intended to focus discussion between residents and faculty, to orient new residents, to identify exemplary as well as unacceptable behavior, and to serve as a component of resident and faculty evaluations. The document has been endorsed by both the AAPMR and the AAP, as well as by leading national organizations such as the AAMC and the ACGME. After careful evaluation, our GME Committee decided to adopt this compact into our residency policy manual.

Annual Board Review Course Draws 230

The 18th Annual Review Course in PM&R was held on April 20 - 28, 2006 at the Westminster Hotel in Livingston, NJ. As in prior years, this year's course attracted attendees who were studying for Part I or Part II of the board exams, or were preparing for recertification. Under the co-directorship of Dr. Susan Garstang and Dr. Steven Kirshblum, 23 of our current faculty members lectured in this course, augmented with five distinguished guest faculty from other institutions. More than 230 physicians attended, of whom 200 were paying registrants. The course was jointly sponsored by the Kessler Medical Rehabilitation Research and Education Corporation and the Department of Physical Medicine and Rehabilitation. Optional sessions were offered in prescription writing, mock oral exams and statistics for the boards. Attendees received up to 80 hours of Category I CME credit.

"UMDNJ Research" Devotes Entire Issue to PM&R

A special issue of the publication *UMDNJ Research* (Spring 2006) has been devoted to the PM&R Department. This issue describes research currently being carried out by our faculty in such areas as stroke, SCI, TBI, movement disorders and neuromuscular disease. New Medical School Is Under Development in Florham Park, NJ

Plans are underway for a new medical school to be located in Florham Park, NJ. The school, to be located in a 75,000

square foot building, will be operated by a private, not-forprofit Jewish organization and has been approved by the NJ

State Board of Medical Examiners. Known as the Touro University College of Medicine, the school expects to enroll about 40 students initially, and then build up to 100 students in each class. It is expected that many of the basic science faculty will be drawn from the Stevens Institute of Technology, while the clinical affiliations may be with the Saint Barnabas system, the Atlantic Health System or the Cathedral system. The next step in the development of this new school will be an application for provisional accreditation by the Liaison Committee on Medical Education. In its application, the school has pointed out that 56% of the residency slots in New Jersey have been filled with foreign medical graduates, a rate that is twice the national average. It is expected that this new school will compete with UMDNJ for access to high quality applicants, faculty, support staff, clinical affiliations and community support, among other things.

Curriculum Committee Targets PM&R Clerkship

The PM&R Department continues to operate a two-week clinical clerkship that is mandatory for all students at New Jersey Medical School. However, we are fighting to retain this mandatory clerkship in future years. This struggle is helped by the fact that Dr. Peter Yonclas, Assistant Professor of PM&R, has been selected to chair the NJMS Curriculum Committee, and in that capacity automatically serves as a member of the Academic Policies and Procedures Committee.

Two developments have occurred since our last issue. First, the "college system," which was previously endorsed as the new framework for the NJMS curriculum and would have reorganized the entire curriculum into four or five new multidisciplinary groupings or "colleges," has been overturned as too costly. Each college would have been expected to develop its own integrated curriculum, and so that model was expected to submerge the PM&R clerkship within other larger specialties. Secondly, the Dean's Office has asked PM&R to incorporate aspects of complementary and alternative medicine into the PM&R clerkship, specifically addressing manual medicine and acupuncture. Our faculty feel there are potentially serious disadvantages posed by this initiative, but we are investigating the issue as requested by the Dean's Office and will submit our recommendations. Meanwhile, the clerkship continues to offer broad exposure to our specialty and serves as an important feeder for the residency program.

Spinal Cord Injury Fellowship Receives PVA Grant

Dr. Steven Kirshblum, Professor and Director of the Spinal Cord Injury Medicine fellowship program, has received a \$50,000 one-year grant from the Paralyzed Veterans of America Research Foundation in support of the SCI fellowship. Dr. Susan Garstang assisted with the preparation of this grant. The PVA Foundation sponsors fellowships for postdoctoral scientists, clinicians, and engineers to encourage training and specialization in the field of spinal cord research. This grant will be used to offset the salary and benefits of one fellow beginning on July 1, 2006, and partially replaces funding that was previously received from the United Spinal Association. The remaining funds that will be needed to operate this fellowship for AY 2006-2007 are being arranged by Dr. Kirshblum.

Kessler and UMDNJ Expand Affiliation for Postdocs

Kessler Institute for Rehabilitation and UMDNJ have agreed to allow Ph.D. psychologists who are training as postdoctoral appointees within the PM&R Department to perform clinical rotations at Kessler under supervision by UMDNJ faculty. This change expands upon the previous affiliation, which was limited to residents, medical students and clinical fellows. This expanded affiliation will strengthen the recruitment of postdocs and support part-time clinical rotations for those trainees whose goals include this exposure.

MGMA Offers Free Patient Safety Tool

The Medical Group Management Association has released a "Physician Practice Patient Safety Assessment" tool that is intended to help medical practices evaluate the impact of their medical office systems on patient safety. This tool is in the form of a questionnaire that probes how various tasks are performed in each practice. Examples of the functions that are examined include screening for potential adverse drug interactions, prescription writing, follow-up on imaging studies, follow-up on requests for consultations, and followup on diagnostic testing orders. There are no right or wrong answers, but MGMA's goal is to understand which functions within medical practices have the greatest potential for improving patient safety.

This questionnaire is accessible at <u>http://www4.mgma.com/survop/patientsafety.htm</u> and will be of interest to many of our alumni, regardless of their practice setting. (Any entries may be entered in "ID" and "Code" to access this tool.) Under a separate project, the American Board of Medical Specialties is working on a similar tool that is expected to be released by the end of

2006. Known as the "Patient Safety Education & Improvement Module," that tool is expected to be available to physicians in all specialties to meet the standards for Part IV of Maintenance of Certification. The common goal of these Web-based tools is to enable physicians to learn about safety and apply this knowledge to care within their own practices.
